## NORMAL WEAR-ITEM COVERAGE<sup>2</sup>

- BRAKE PADS  
Replacement of one (1) set of front and one (1) set of rear brake pads and brake lining/shoes
- BATTERY  
Replacement of one (1) 12-volt automotive battery
- BELTS AND HOSES  
Unlimited replacement of engine belts and hoses<sup>4</sup>
- WINDSHIELD WIPER BLADES  
Replacement of one (1) set of windshield wiper blades and/or inserts
- WHEEL ALIGNMENT  
One (1) wheel alignment service
- BULBS AND FUSES  
Unlimited replacement of fuses and interior/exterior light bulbs including LED lights<sup>4</sup>
- EXTERIOR LAMP ASSEMBLIES  
Unlimited replacement of headlamps, fog lamps, and center stop lamp<sup>4</sup>
