## TIRE & WHEEL PROTECTION WITH OPTIONAL COSMETIC COVERAGE

### REPLACEMENT OF TIRES AND WHEELS

Covers structural damage due to road hazards such as nails, glass, potholes, rocks, or debris or due to a defect in material or workmanship. Also covers associated repair costs and provides continued coverage for the replacement tire or wheel.

### COSMETIC WHEEL REPAIR

Optional Cosmetic Coverage covers repair of nicks and scrapes on wheels.

### ADDITIONAL BENEFITS

Towing expenses up to \$100 per occurrence. No deductible, no limit to the number of covered structural damage claims, and no mileage limitations.

## PAINTLESS DENT REPAIR

### REMOVES MINOR DENTS AND DINGS

Permanently removes minor dents and dings up to four (4) inches in diameter using paintless dent repair process.

### HAIL DAMAGE COVERAGE

Covers hail damage up to the dollar value of your comprehensive damage deductible (if claim filed with primary insurance) or \$1,000—whichever is less.

### ADDITIONAL BENEFITS

No deductible, no limit to the number of covered claims, and no mileage limitations.

### EXCLUSIONS<sup>1</sup>

Damage to tires with less than 3/32" tread depth when damage occurs, normal wear and tear, vandalism, or road conditions found in construction sites/zones. Cosmetic damage to tires. Cosmetic wheel repair is limited to sanding, painting, or refinishing the wheel without the need to apply additional material or bend/straighten the wheel. Cosmetic wheel repair limited to a total of six (6) individual wheel repairs during the agreement term.

### EXCLUSIONS<sup>1</sup>

Dents or dings that are larger than four (4) inches in diameter, that are not located within an accessible area or that cannot be repaired by the paintless dent repair process. Damage caused by vandalism. Repairs that will affect or damage the vehicle's paint or finish. Hail damage coverage is not available in Alabama.

## WINDSHIELD REPAIR PROTECTION

### REPAIR OF MINOR CHIPS AND CRACKS

Covers repair of minor chips and cracks in the front windshield caused by propelled rocks and other road hazard debris while driving on public roads, streets, and highways.

### UNLIMITED REPAIRS

Covers unlimited repairs of the front windshield during the coverage period.

### ADDITIONAL BENEFITS

No deductible and no mileage limitations.

### EXCLUSIONS<sup>1</sup>

Replacement of the front windshield. Damage to areas other than the front windshield. Stress cracks or cracks over six (6) inches. Damage caused by hail, vandalism, or neglect. Damage that, if repaired, would result in an obstruction of the driver's line of sight. Windshield Repair Protection is not available in Arizona or Florida.

## KEY REPLACEMENT PROTECTION

### REPLACEMENT OF VEHICLE KEY/REMOTE

Replaces covered vehicle key/remote if lost or damaged, up to \$800 per occurrence.

### LOCK-OUT ASSISTANCE

Covers assistance to unlock the covered vehicle if your keys are lost, damaged, or locked inside, up to \$100 per occurrence.

### ADDITIONAL BENEFITS

Towing expenses up to \$100 per occurrence. Taxi/rental vehicle/public transportation reimbursement up to \$75 per occurrence. Replacement benefit for additional non-programmable keys on the key ring up to \$250 per covered key claim for a total of up to three (3) occurrences.

### EXCLUSIONS<sup>1</sup>

Replacement keys, if two (2) master keys were not provided at time of vehicle lease/purchase, or if damaged keys are covered by the manufacturer's, repairer's or supplier's warranty or recall. Any replacement keys made without prior authorization. Any costs associated with reprogramming the vehicle's main body engine control unit. Any aftermarket keys or remote devices.
